The 31st World University Games 2021 is scheduled to be held at Chengdu (China) from 18th – 29th August 2021. Association of Indian Universities (AIU) has entrusted the responsibility of conducting the selection trials of Indian Universities Athletics (Men/Women) Teams at KIIT – Deemed to be University, Bhubaneswar.

In this connection, you are requested to send the eligible men and women players of your university to participate in the selection trials of Indian University Athletics (Men/Women) teams scheduled from 07th to 10th March 2021 at KIIT- Deemed to be University, Bhubaneswar.

The players attending the selection trails should produce the following documents at the time of selection trails:

1. Eligibility proforma duly signed by the University Authorities (Two copies).
2. Identity Card of the Current Session.
3. Valid Indian Passport (Original & Xerox Copy).
4. Four passport size photo.

The FISU General Regulations for participation (Annexure - I) & Sports Specific Eligibility (Annexure - II) criteria prescribed by the organising committee for participating in the selection trails is attached here, along with SOP guidelines from Govt. of India and FISU entry standards.

Further, registration Fee of Rs. 1000/- per athlete and during the selection trails, the lodging and boarding facilities will be provided at University campus by depositing Rs. 500/- per day/per person. The selected players have to attend coaching camp and the information of the same will be conveyed to the respective universities in due course of time.

During the selection trail, NADA is going to conduct the dope test of all players of which will be conducted at the Venue as per NADA regulations.

Interested players should report with all above documents at Office of the Director Sports, KIIT Hockey Stadium, Campus 13, KIIT – Deemed to be University on 05th March 2021 and confirm their entries by mail – sports@kiit.ac.in on or before 28th February 2021. Any other information regarding selection will be updated accordingly on our website www.kiit.ac.in .


